The membership recited the Pledge of Allegiance to the Flag of the United States of America.

Bob McCulloch gave the invocation.

President King stated that the minutes of the previous meeting were published in the *Grapevine* and would be read if so desired. A **MOTION** was made by Cecil Handy to accept the minutes, seconded by Robert McCulloch and was passed.

**Vice President** - Frank Williams recognized the division representatives for their excellent work and asked that if anyone knew of someone who was ill, to please pass that information along to your representative.

**Secretary's Report** - Nothing to report.

**Treasurer's Report** - Phyllis Allgood reviewed the thank you notes she had received.

**Health and Welfare Report** - Ron Maxey gave an update on several of the members.

**Executive Secretary's Report** - Dave Copley advised of the following conferences:

The Summer Meeting will be held in Charlottesville at the DoubleTree by Hilton, 990 Hilton Heights Road on July 27, 2019.

The Winter Meeting will be held in Virginia Beach at the Four Points by Sheraton Virginia Beach Oceanfront, 1211 Atlantic Avenue, on November 16, 2019.

The Spring Meeting next year will be held in Natural Bridge on April 25, 2020.

### Division Representative's Reports:

Reports were given by several of the Division Representatives.

### Old Business

a. Results from the survey regarding the number of meetings per year - Art King reviewed the results of the survey returns that showed 77% of the surveys returned recommended two meetings per year, there were 16% that recommended staying with the three meetings per year and the remaining 7% did not have a preference. Art King appointed a committee to draft the new by-laws allowing two meetings per year, and the proposed revisions will be published in the next *Grapevine* to be voted on at the Summer Conference.

### New Business

a. Art King said Colonel Settle was to have been the speaker at the dinner meeting, however, he had attended the IACP Meeting in Texas and due to high winds, his flight was delayed and would be unable to attend. Art introduced Major Rex Taylor, Deputy Director of BCI and said he would be giving an update on the Bureau of Criminal Investigation during this General Membership Meeting. He will be the speaker for the dinner meeting to give an update on the Department's activities (legislation, changes in bureaus, etc.)

b. Major Taylor gave an overview of the Bureau of Criminal Investigation discussing some of the personnel changes due to retirements, promotions, etc, division changes, new initiatives and a new BCI/BFO Internship Program.

There being no further business, a **MOTION** to adjourn was made by Rodger Macy and seconded by Jim Rexrode, the motion was approved.

The meeting was adjourned at 4:00 p.m.

ARTICLE XI, SECTION 1: In keeping with this article the below changes are being presented as a notice to the membership for approval at the Summer Conference.

The proposed changes listed are based on the assumption that the two Membership Conferences/Meetings will be held during the Spring and Fall quarter of each Calendar year. This allows for a 90 day window for meeting planning and scheduling. This change will require that nominations be announced at the Spring meeting and voted on at the Fall meeting.

### CHANGES TO POLICIES

#### VSPA GRAPEVINE

4. The Second Issue of the Grapevine for the calendar year must include the nominations for all elected positions accepted at the Spring meeting as required by Article VII, Section 1 and Section 2 of the VSPA Bylaws. Nominations include the regular Officers and Division Representatives.

### CHANGES TO BYLAWS

#### ARTICLE VII

#### ELECTIONS

##### SECTION 1: NOMINATIONS

The President shall accept nominations for the elected positions at the regular meeting held in the Spring of each year. Nominations must be duly seconded. There shall be no limit to nominations for any given office. These nominations shall be recorded in the minutes. Additional names may be placed in nomination from the floor at the time of balloting.

##### SECTION 2: TIME OF ANNUAL ELECTION

Elections shall be held at the Fall regular meeting of each year. At least two (2) weeks prior to the annual election, each member shall be given written notice of the nominees and the time and place where the elections are to be held.

#### ARTICLE VIII

#### MEETINGS

##### SECTION 1: MEETING OF THE MEMBERSHIP

Two membership meetings shall be held each year. The time and place for each meeting shall be selected by the Executive Board. Normally, meetings should be (1) Spring, (2) Fall. Due consideration should be given to all meeting requirements.

##### SECTION 3: QUORUM

A quorum shall exist when twenty (20) or more sworn and non sworn members are in attendance.
